Besides attested Aadhar Card photocopies, Parents have to bring the **Original Date of Birth Certificate** issued by the Municipal Corporation and a photocopy of the same duly attested by Class A gazetted officer.
- 04. Correct information must be given in the Admission Form. Date of birth, spellings of names of Father, Mother and Child must be written correctly in **BLOCK LETTERS**. No change or correction will be entertained once the entries are made in the School Record.
- 05. All documents presented at the time of admission become the property of the school and will not be returned. Fees once paid at the time of admission will not be refunded. There is no provision to surrender the seat once the admission process is complete.
- 06. The fee structure for New Nursery Class starting from 2024-2025 is available on the School website. Fee may be increased for the year 2025-2026 and likewise in the following years.
